## **4.2** Industry Standards Committee Report

Craig Mathes tabled a report on the September 11, 2019 meeting of the Industry Standards Committee (ISC) and the following motions:

## Apprenticeship Program Amendment Order

The proposed *Apprenticeship Program Amendment Order* amends the *Apprenticeship Program Order* (Board Order 1/2009) by changing the entrance requirements for the sheet metal worker apprenticeship program from "Category A" to "Category "B". The amendment is consistent with the Sheet Metal Worker PAC recommendation and the board's approval to align the sheet metal worker classroom instruction with content from the gasfitter apprenticeship program.

The board approves the proposed Apprenticeship Program Amendment Order.

## • Designated Occupations Training Program Amendment Order

The proposed *Designated Occupations Training Program Amendment Order* amends section 4 of the *Designated Occupations Training Program Order* (Board Order 4/2010) by changing references to "construction craft labourer" to "construction craft worker". The amendments are consistent with the new occupation name approved by the board and the Minister under the *Designation of Occupations Regulation* (AR 285/2006) and the *Construction Craft Worker Occupation Regulation* (AR 270/2000) in 2017.

## • Hairstylist Implementation Date Change

The proposed Hairstylist Trade Regulation was approved by the board at its September 28, 2018 meeting (Motion 2018-10-68). However, ministerial approvals for the regulation were delayed due to the provincial election and the subsequent change in government. The revised regulation changes references from April 1, 2019 to April 30, 2020. This change is consistent with the proposed new implementation date for the regulation. All other amendments remain the same.

#### • Tilesetter De-designation

The committee was presented with results of a survey, which supported a motion made by the Tilesetter PAC to recommend the de-designation of the tilesetter apprenticeship program. A history of the Tilesetter PAC motion to de-designate the apprenticeship program and the steps taken to ensure that there was consultation with, and feedback from, all aspects of the industry was also provided.

The committee had a discussion regarding compulsory versus optional certification status of apprenticeship programs and concluded that compulsory certification has little impact on apprentice registration numbers.

## • Industrial Construction Crew Supervisor Program Recognition

Worley has purchased the division of Jacobs Engineering that delivered the Jacobs Development Program, which has board recognition applied toward the Industrial Construction Crew Supervisor (ICCS) certification. Now called the "Worley Leadership Development Program", the ICCS Occupational Committee has reviewed the two programs, acknowledges the similarities, and has recommended the board grant recognition toward ICCS certification for the Worley program.

#### • Blue Seal – Athabasca University

## • Blue Seal – Grande Prairie Regional College

Grande Prairie Regional College, an approved training provider, requests that the board approve changes made to its previously approved Management Essentials Certificate program. The committee reviewed and recommended approval of the changes made to the program.

#### • Rig Tech Dedesignation

John Brosda advised that prior to de-designation of the trade, 270 apprentices who have been inactive for 18 months or more will be notified that their contracts are cancelled. The individuals that are just missing hours will get called and asked to send in their record books so they can be completed.

There is a communications plan in place and a hotline set up to answer questions or concerns directed to them.

There was a concern about what kind of message this initiative sends given all the current promotion of the skilled trades. Minister has been briefed on the issue to ensure there will be proper communication provided.

This item will come back to the Board at its November meeting with additional information being provided on the outcome of the apprentice communication strategy. The Board will also be asked to consider the information presented and to provide advice to the Minister regarding the de-designation request.

## • Sprinkler Systems Installer Re-designation

John Brosda noted the Apprenticeship and Industry Training staff facilitate these requests to move forward to the Board at the appropriate time and that there is no consultative role in the process. He advised that more detailed information regarding this process and the specific request to re-designate this program as a compulsory certification program will be provided at the next ISC meeting to ensure board members are fully aware of all the work done to date.
