Delanee discussed the struggle to find qualified tradespeople in several trades, including HET.

## 2.3 Executive Director's Report

The Director, Apprenticeship Delivery and Industry Support Services gave the update for the Executive Director.

There are currently 39,922 registered apprentices, which is down 9% from the previous year, however, there are 5,022 new registrations which is up 32 % from 2020.

There have been 9,381 cancellations which is up from 2020 but this is due AIT lifting the freeze on overdue cancellations. AIT is now up to date on overdue cancellations.

There have been 12,531 registrations in 1<sup>st</sup> period which is up 5 percent from last year.

Over 2 million has been awarded to apprentices through the Apprentice Training Award.

The STAE Act was discussed by attendees. The Director confirmed that the Act has passed but has not yet been proclaimed (come into force) and that engagement with stakeholders was presently taking place. The email address to send in comments and inquiries was given to attendees again for future questions.
