## 2. BOARD AND EXECUTIVE REPORT

## 2.1 Board Chair's Report

The board chair reported on her past and upcoming meetings and events including:

- Alberta Workforce Essential Skills Meeting.
- Canadian Council of Directors of Apprenticeship National Stakeholders Meetings.
- Canadian Apprenticeship Forum Executive meetings.
- Alberta 2030 Roundtable for industry representatives.
- Alberta Trades Hall of Fame Inductee Event.
- Apprenticeship and Industry Awards of Excellence.
- Board Chair mentioned the Canadian Apprenticeship Forum National Conference is coming up on February 22-23, 2021.

### 2.2 Board Members' Reports

Board members reported that they participated in industry events and meetings since the last board meeting including PAC/OC meetings as Board Liaisons. In addition, some board members provided comments on the current state of their industry. Some board members attended the Alberta Trades Hall of Fame Inductee and/or the Apprenticeship and Industry Awards of Excellence virtual events.

### 2.3 Executive Director's Report

- All Apprenticeship and Industry Training Client Services Offices are open and adapting to the COVID-19 health guidelines.
- Department's reorganization is ongoing and the Apprenticeship and Student Aid division will become the Operations and Client Service Delivery Division. Industry Program Services and Board support will move to Operations and Client Service Delivery Branch, which will be responsible for all aspects of apprenticeship delivery and related industry support under one executive director.
- Industry Committee Network meetings have for the most part successfully transitioned to virtual meetings. PAC meetings are all held virtually and LAC meetings are held either in-person and virtually due to less attendees.
  - $\circ~$  The Skills for Jobs Task Force final report is expected to be released by the government soon.
  - Information from the federal government's quarterly reports on the Apprenticeship Incentive Grant, Apprentice Completion Grant, and Apprenticeship Incentive Grant for Women was shared with the board.
  - Registered Apprenticeship Information System (RAIS) recent information on how societal factors impact the time it takes apprentices to complete their program. - Red Seal exam update:
  - There are 1,800 final period apprentices eligible to write the Red Seal exams in the first two outgoes for this academic school term.
  - An additional 4,000 potential Red Seal exams between January and June 2021 (based on current registration statistics). The first outgo had 491 eligible final period apprentices, out of which 468 attended one of the offerings. This represents a 95% participation rate, which is higher than our typical participation rate over the last three years of 85%.
  - Many of the apprentices that did not attend have rescheduled an IP exam in one of Apprenticeship and Industry Training offices.
  - The department will continue to need flexibility in apprenticeship progression, including the likelihood of extending apprenticeship period exam exemptions until the end of the 2020/21 school term.

- There are currently 14,288 apprentices registered for classes, an increase from last year's registration of 12,024 apprentices.

- The board asked if students' pass and fail rates have been impacted by COVID. The institutions reported that pass and fail rates differences were negligible when compared to previous years.
- The board asked how students are adapting to blended learning. The institutions reported that apprentices attend classes virtually for a portion of time and attend campus for hands-on lab/shop activities which cannot be replicated in a virtual environment. Overall, the apprentices are adapting well.
